## Overview

## Representative Cases

- Stephen Hull v. Wheeling Police Pension Fund – Circuit Court of Cook County – affirmation of pension board ruling denying a line-of-duty disability pension based on alleged psychological conditions.
- Santana v. Village of Maywood – Circuit Court of Cook County – obtained dismissal of a complaint for personal injury from a trip and fall, based on the theory that a pedestrian is not an intended user of a portion of a street that is outside of a crosswalk.
- Collins v. Village of Niles – Circuit Court of Cook County – affirmation of the denial of benefits under the Public Safety Employee Benefits Act (PSEBA), based on a firefighter’s career-ending injury sustained during a training incident.
- LNR Family Store, Inc. v. Village of Maywood, 2020 Ill App 1-19-1417 – Illinois Appellate Court, 1st District – affirmation of the dismissal of a Circuit Court complaint alleging due process violations under the 6th and 15th Amendments, based on the Village's revocation of the business and tobacco licenses of a nuisance business.
- Beckett v. Village of Maywood – Circuit Court of Cook County – obtained summary judgment on a complaint for personal injury from a parkway trip and fall, based on the Village’s lack of notice of the specific defect.
- Olson v. Lombard Police Pension Fund, 2020 IL App (2d) 190113 – Illinois Appellate Court, 2nd District – affirmation of a pension board ruling denying a line-of-duty disability pension allegedly caused by cumulative on and off-duty incidents.
- Colella v. Village of Lombard - Circuit Court of DuPage County – obtained dismissal of a complaint for personal injury based on Village's lack of notice of a defective condition of a walking path inside of a Park District wooded area.
- Macchione v. City of Aurora – Circuit Court of Kane County – obtained dismissal of a complaint for personal injury caused by a criminal incident that occurred on City-owned property adjacent to a casino.
- Schroedle v. Village of Orland Park – Circuit Court of Cook County – obtained summary judgment on a complaint for personal injury from a sidewalk trip and fall, based on the Village’s lack of notice of the specific defect.
