## Overview

Kaylee Hartman is an Associate Attorney with Klein, Thorpe, and Jenkins, Ltd. She graduated *cum laude* with a B.S. in Sociology and English from Florida State University in 2016 and again in 2018 with a Master of Arts in Higher Education and Student Affairs from The Ohio State University.
