## Overview

Lance graduated from the Chicago Musical College of Roosevelt University in 1984 with a Bachelor of Arts degree, with honors, in Music Performance and received his Juris Doctor degree from DePaul University, with honors, in 1989, where he graduated number one in his class.

While attending law school, Lance received eight awards for excellence in courses taken and three awards for outstanding scholastic achievement, including two scholarships. He served as the Managing Editor of Lead Articles for the DePaul Law Review in 1988—89. He is a member of the Illinois State Bar, the U.S. District Court for the Northern District of Illinois, the U.S. Court of Appeals for the Seventh Circuit and the United States Supreme Court.
